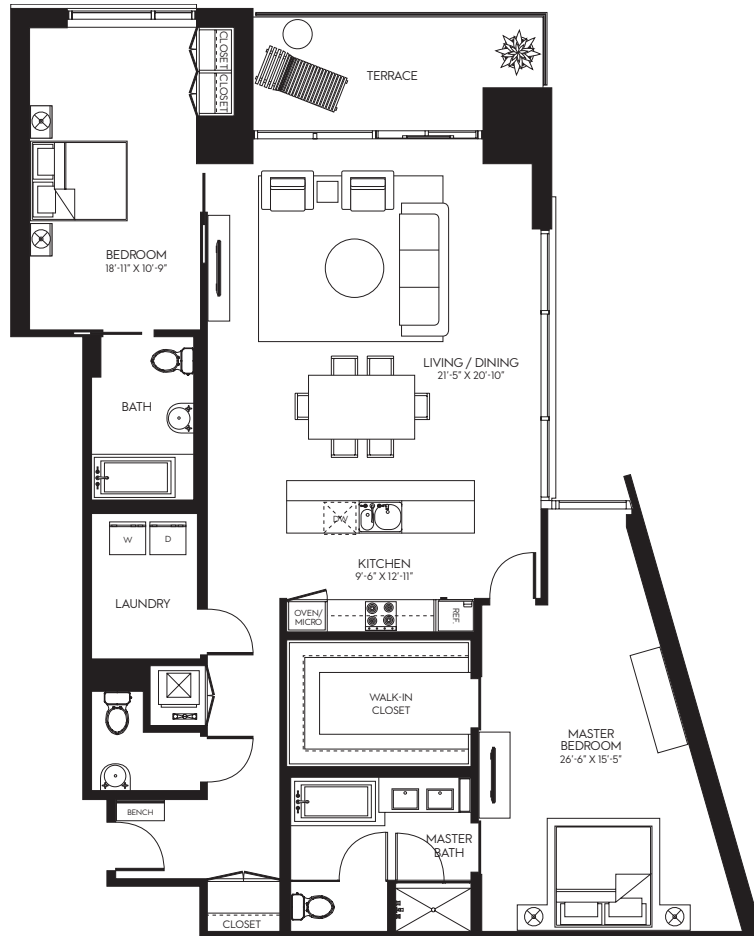
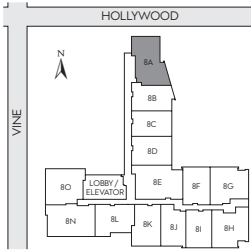

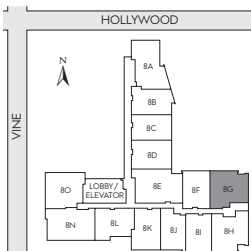
Plan A

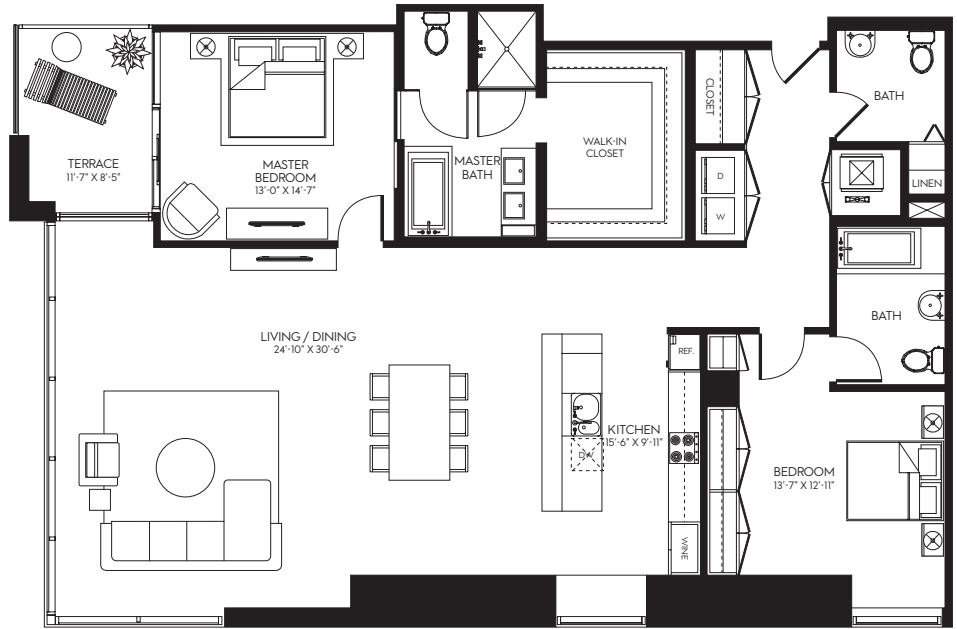
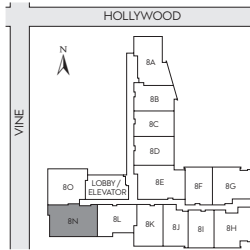
Plan G

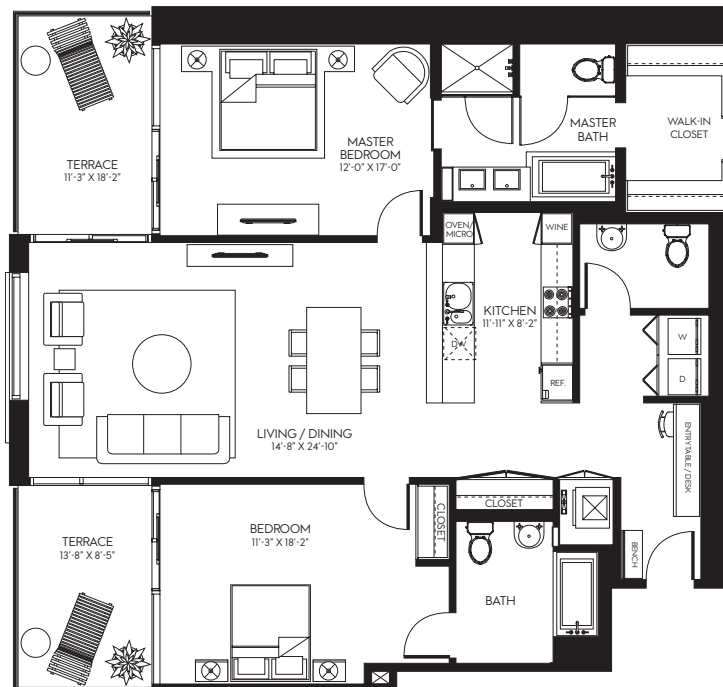
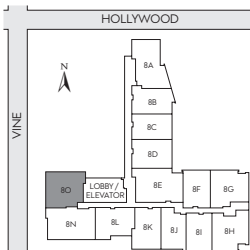
